The Town Council approved the annual renewal, however, Mr. Chin was summonsed for non-compliance of the conditions of renewal due to the fact he owed tangible taxes and failed to submit his Permit to Make Sales at Retail.

Mr. Chin has since payed \$1,707.42 through Rossi Law, however, a balance of \$1,890.41 still remains. Mr. Chin has still not submitted a copy of his Permit to Make Sales at Retail.
