Option I. Half Court Sponsorship

For Option I, the individual's, families' or business' name will be prominently displayed within the circle of center court and will be included in future correspondence (i.e.; written invitations, social media posts, etc.) relative to scheduled events. For example: "The Grand Opening of the Anna McCabe Courts sponsored by _____"

The Fee for this sponsorship will be \$10,000. Your sponsorship would be for a FIVE year term.
There are two sponsorships available for Court #1 and Court #2.

Options II. Scoreboard Sponsorship

For Option II, the individual's, families' or business' name will be prominently displayed on one of the permanent scoreboards, and will be included in future correspondence (i.e.; written invitations, social media posts, etc.) relative to scheduled events. For example: "The Grand Opening of the Anna McCabe Courts sponsored by _____"

The Fee for this sponsorship will be \$5,000. Your sponsorship would be for a FIVE year term.
There are two sponsorships available for Score Board #1 and Score Board #2.

Option III. Side Court Sponsorship

For Option III, the individual's, families' or business' name will be prominently displayed on the court in a 2'x3.5' area. The sponsor will be included in future correspondence (i.e.; written invitations, social media posts, etc.) relative to scheduled events. For example: "The Grand Opening of the Anna McCabe Courts sponsored by _____"

The Fee for this sponsorship will be \$5,000. Your sponsorship would be for a FIVE year term.
There are two sponsorships available for Score Board #1 and Score Board #2.

A brief, written explanation of why the individual, family or business should be selected **must** accompany each application. Selections will be made by the Anna McCabe Basketball Committee which shall take into consideration sponsorship amount **and** the written explanation. These sponsorships will remain in effect for the terms mentioned above, unless circumstances (i.e.; dishonor, reputation, request of the family/business, etc.) as determined by the Smithfield Town Council dictate that a name replacement is in the best interest of the Town.
